Maximum of (2) FFA/4-H members per pumpkin to decorate. FFA/4-H members are permitted a younger sibling to assist if they are not of FFA/4-H age/grade eligibility.

FFA/4-H member(s) may decorate his/her pumpkin in a creative way, using props and decorations from home. Pumpkins and paint will be provided BUT you may bring your own paints.

No carving tools will be permitted.

One entry per FFA/4-H member(s).

Pumpkins should be lovable, mischievous, and humorous - not frightening. "Scary" witch or monster faced pumpkins will be disqualified.

The entry artwork/decorating must be done by the FFA/4-H member(s) assigned to that pumpkin. No adult assistance is allowed.

No electricity will be available for hot glue guns.

Pumpkins will be judged on creativity (10 pts), originality/presentation (10 pts), and craftsmanship attention to detail and neat in appearance (10 pts).

ALL PUMPKINS MUST BE PICKED UP AFTER THE FAIR ON SUNDAY OR MONDAY. ANY REMAINING AFTER 4 PM MONDAY, NOVEMBER 4, WILL BE DISPOSED OF.
